

Market wrap last week

Global stock markets experienced a positive week. The S&P 500 reached a new record high, while the STOXX Europe 600 and the DAX neared their all-time highs. Markets overlooked geopolitical concerns, hurricanes, and weaker US jobless claims, focusing instead on earnings surprises, optimistic comments from NVIDIA, and Federal Reserve policy. In the US, the headline CPI growth rate slowed to 2.4% from 2.5% in August. Additional data, including the September PPI and preliminary October consumer sentiment, supported expectations of continued Fed rate cuts. The ECB expressed confidence that inflation would return to target by the end of 2025. Earnings results from JPMorgan Chase, Wells Fargo, and BlackRock received positive responses.
