



Market wrap last week

European equities extended gains for the 10th consecutive week, with Stoxx 600 and FTSE 100 at record highs, while CAC 40 declined (-0.67%). Banks, Insurance, and Utilities outperformed, while Media, Technology, and Basic Resources lagged. Defense stocks surged, with Rheinmetall (+12.2%) and BAE Systems (+12.2%) leading gains amid €500B EU military spending proposals. CDU-SPD coalition talks began in Germany, with Merz pushing for €200B defense spending, raising expectations for fiscal loosening. Trump's 25% tariff threats on EU autos, semiconductors, and pharmaceuticals added pressure, while Eurozone inflation eased, supporting ECB rate cut expectations.

Strengthening shareholder relationships has become the top priority for over half of IR professionals, reflecting a push for stability amid market volatility. However, 71% still struggle with investor targeting, particularly mid-caps, where this challenge is even more pronounced. Meanwhile, technology adoption is increasing, but integration challenges persist, and AI adoption remains cautious, with security concerns slowing implementation.
